APPLICATIONS:

1. Submit 5 photos of your work. Include one of your setup, one showing you working on your work in progress and one of your supplies and tools.
2. Your product should be hand made by YOU. If your items are found not to be made by you, YOU WILL BE ASKED TO LEAVE AND NO REFUND WILL BE GIVEN.
3. If you were in our show last year, you need **not** submit photos unless you have added or changed media or unless requested to do so by the committee.

SPACE RENTAL:

1. Space rental fee is \$80.00 for the entire 3 days of the show. A space is considered 10' deep x 15' across. ALL PRODUCTS & displays must stay within the lines of your space
2. Rental fee supplies only the space for your exhibit. You must supply your own tables, etc.
3. Each exhibiting artist is responsible for his/her own artwork, props and should have a responsible person in attendance at all times.
4. Your area must be kept neat with storage items stacked neatly or out of sight.
5. To reserve your space for next year, a deposit of \$40.00 is required.
6. No Smoking in your Rental Space

SPACE ASSIGNMENT:

1. Entry fees are non-refundable.
2. Spaces will be assigned based on all information supplied.
3. Spaces will be assigned on a first come first serve basis.
4. Full payment must be made to the Festival office by **July 1st** or your space won't be confirmed.
5. When all available spaces are assigned, a waiting list will be used in case of cancellations or lack of full payment. **For anyone reserving a space after July 1st, payment must be made in full before arriving at the show.**
6. If you do not attend the show after reserving a space and do not notify us a week before the show, **you will not be accepted into the show the following year.** Please keep the committee informed of any changes ASAP. Thank you.

SET-UP:

1. **NOTHING** MAY BE PUT INTO THE LAWN **OR** BLACKTOP (POLES, STAKES, ETC.) FOR THE PURPOSE OF ERECTING **OR** DISPLAYING.
2. If any damage is done to the lawn sprinkler system or blacktop, the exhibitor will be held responsible.
3. NO ONE WILL SET UP BEFORE 5:00PM THURSDAY.
4. EVERYONE MUST CHECK IN BEFORE SETTING UP.
5. **Set-up Times: Thursday 5:00 pm to 8:00pm, Friday 8:00 am to 9:30 am**

5. All exhibitors are required to remain open for the full-published hours of the Arts & Crafts Show. Any exhibitor not adhering to this rule will not be accepted the following year.

UNLOADING/PARKING:

1. Parking around the Courthouse Square, Third St., Huron St., Second St. or Michigan St. is STRICTLY PROHIBITED to exhibitors during the show hours.
2. You will unload your vehicle in 15 minutes, move your vehicle, and then set up your display. You will not set up while you are unloading.
3. There is no parking in the North parking lot of the Courthouse on Thursday, Friday & Saturday. Daily crafter parking is north of Third St. between Erie and Michigan streets.
4. Temporary camping for crafters, in self-contained units, will be located on Huron St. between the high school and the elementary school. Camping is by permit only from the Festival committee. Permits will be available when checking in on Thursday.

SECURITY:

1. Security is provided from 9:00PM through 8:00AM on Thursday, Friday and Saturday.
